Dear Ms. Trotta:

The City of Bentonville has completed the South Lift Station Renovation and Force Main Upgrade Project as of November 20, 2015. The project was deemed substantially complete on October 16, 2015 with all items installed. Punch list items have been corrected and the station and associated force main are fully operational. This project brings the City into compliance eliminating recurring sanitary sewer overflows associated with high flow events near the South Lift Station. Said overflows were historically reported at 1706 SE Walton Boulevard.

This project has increased the capacity of the lift station to handle additional demand and potential development as well as anticipated infiltration during significant rain events. With this project, the pump rate for one pump running increased from 900 gpm to slightly over 1500 gpm. The pump rate for two pumps operating more than doubled from an average of 950 gpm to an average of 2,100 gpm, and the three pump average increased from 975 gpm to 2,500 gpm.
