## Dear Ms. Trotta:

The purpose of this correspondence is to provide a quarterly project update for the South Lift Station Renovation and Force Main Upgrade Project. This quarterly update is due by July 5, 2015. The following summarizes project activity from April 1, 2015 through June 26<sup>th</sup>, 2015.

- Forsgren, Inc. continued construction installing approximately 6,000 linear feet of 16" force main bringing the total length installed to 12,985 linear feet. The project consists of approximately 15,100 linear feet of force main with approximately 2,100 linear feet remaining to be installed.
- Approximately 5,400 linear feet of the force main has been pre-tested. The contractor is currently working on pre-testing an additional 6,900 linear feet.
- Restoration has been completed on approximately two thirds (2/3 or 0.6667%) of the project.
- The contract was scheduled to end April 16, 2015; however, winter weather from
  the previous quarter along with excessive rain during this quarter has negatively
  affected the project. We have also encountered alignment issues/conflicts with
  other existing utilities. Adjustments have been slow as the sites are also located
  on developing properties. Coordination has been progressing; however due to
  proposed designs for the development of property, realignment design has been

slow. Weather delays and adjustments outside the control of the contractor will extend the contract time. If final adjustments can be completed timely in the next week and weather cooperates, the project should be complete within 90 days.
