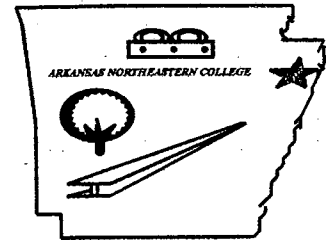

The last 12 months mercury tests results are as follows beginning July 2013 for your review.



The Blytheville Wastewater Department will possibly begin issuing wastewater discharge permits to facilities that tested positive for mercury in their discharge to the City. Our

focus is on our dental offices to determine if they have a properly operating amalgam separator installed at their facility. There are no industries discharging to this treatment plant only residential and light commercial facilities.

I am submitting a final compliance and status/progress report for copper discharges from our west treatment plant.


After reviewing the previous 12 months of copper data, we believe there is no reasonable potential to exceed our permits limits for copper. Our highest result was 23.7 ug/L in February 2014 and our average seems to be at 10.4 ug/L.

Also, The City will be contracting SSR Ellers engineering out of Memphis, TN in developing a detailed Corrective Action Plan on mercury discharges and the effluent violations for the period of March 1, 2014 through May 31, 2014.

I understand this CAP is due by September 19, 2014? or August 28, 2014 as specified in your letter?
