1. Introductions
2. Violations:
 - a) DEQ asked about updates that were made at the facility
 - b) The City of Dumas stated that repairs were made to the automatic sulfur delivery for the de-chlorination system. These repairs were finished in October 2023.
 - c) DEQ stated that there had been 18 violations of TRC from July 1, 2020 to November 30, 2023.
 - d) These violations placed the City of EPA's Significant Non-Compliance (SNC) List.
3. Request for a Revised Corrective Action Plan:
 - a) DEQ requested a revised CAP from the City
 - b) Dumas stated that McClelland Engineers would draft a revised CAP and send it to DEQ. McClelland would also assist the City in identifying the areas in the plant that need to be corrected.
 - c) The revised CAP should have a milestone schedule and final date of compliance.
4. Consent Administrative Order:
 - a) DEQ explained that because the city was on EPA's SNC list, a CAO would have to be issued to address the violations.
 - b) The CAO would incorporate the dates from the revised CAP that would be submitted.
 - c) The CAO would include a civil penalty.
 - d) It should be proposed after the 1st of the new year.
5. Other Areas of Repair:
 - a) Dumas stated that a contractor will be brought in to repair the aerators, staff gauge and assist with cleaning
 - b) Dumas will submit a report detailing the work that has been completed and a milestone schedule for other items to be completed
6. Other Concerns:
 - a) Dumas asked about a time extension before a CAO was proposed.
 - b) DEQ discussed that the violations had been occurring for several years and that per the agreement with EPA, DEQ is required to address this with formal enforcement. Dumas asked where and to whom the reports should be sent.
 - c) DEQ stated that the reports can be sent to Tom Harrington

- b) DEQ will send proposed CAO
- c) City of Dumas will send DEQ the revised CAP and progress report detailing the improvements that have been made by January 15, 2024
