This letter is to inform you of the City of Yellville's non-compliance with effluent Limitations for the month of October 2012.

1. Description of Violations

- a. NH3-N mg/l, NPDES 7 Day AVG 1.5, Reported 10.6

2. Reason for Violations:

- a. Due to an air leakage from our blowers going to the aeration unit an inadequate amounts of air was being deliver.

3. Duration of the Violation:


- a. We believe that the air leak has been an on going problem for several weeks.

4. Corrective Action Taken to Eliminate Violations:

- a. Plant Personnel has repair the leak and new diffuser have been install on several of the banks of our diffuser racks. Information received from our testing lab has shown that the repairs have brought our levels on NH-N mg/L into permit requirement.

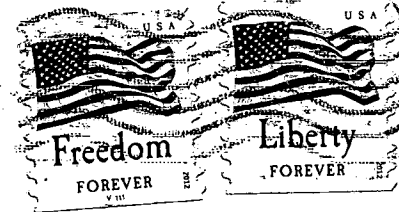
