2023 Year-End SSO Report

Dear Mr. Healey:

On behalf of Malvern Water Works, I am submitting the 2023 Year-End sanitary sewer overflow (SSO) Report.

All 2023 SSOs were reported in accordance with Part II of NPDES permit AR0034126. Malvern has continued to implement the Bacteria Sampling and Communication Plan as approved by the Division of Environmental Quality (DEQ) on March 15, 2023. Work completed to date to correct the ongoing SSOs is detailed in the attached quarterly progress reports. These reports are a requirement of the corrective action plan (CAP) approved by DEQ on December 6, 2022.

SSOs are a direct result of inflow and infiltration in the collection system in tandem with capacity limitations at the Walco Road pump station. As part of the 2023 sanitary sewer evaluation survey (SSES) report scheduled to be complete in the Spring of 2024, preliminary smoke testing and sewer main closed-circuit television (CCTV) data has been provided to Malvern to facilitate and prioritize the required corrective work. To date, Malvern has eliminated several sources of I&I and is continuing to do so as more data from the SSES is received.

In December 2022 Malvern Water Works self-performed an open cut replacement of the 6" clay sewer main that connects MH 154 and MH 155 with new 6" SDR-26 PVC. This was in response to their inability to inspect the segment by CCTV due to offset joints and root intrusion. During the replacement they located three (3) inactive sewer service lines and filled them with flowable fill before abandoning them. It was also discovered that stormwater collecting in the nearby curb inlet was flowing into the old sewer main through a large pipe fracture.

In total, four (4) sources of inflow and infiltration (I&I) into this critical pipe segment were identified and eliminated. After a significant wet weather event post open cut replacement, Malvern noticed that the water level in MH 155 was lower now than it had been during past wet weather events of similar intensity, indicating that the self-performed pipe replacement is already helping to reduce and eventually eliminate sanitary sewer overflows (SSOs) at MH 154 and MH 155.

In January 2023 Crist Engineers surveyed MH 154, MH 155, and 19 additional manholes upstream and downstream of the Laurel and Davis intersection. Information gathered from this survey includes MH rim elevations, sewer invert elevations, and sewer pipe diameters. This information will allow us to build a hydraulic profile of the area that will aid in verifying pipe capacities, segment slopes, and potential bottlenecks that may also be contributing to the Laurel and Davis SSOs.

Over the next several weeks, the City of Malvern plans to engage Crist Engineers and RJN Group to begin planning for the proposed corrective action work as shown in Table 1. The milestone schedule submitted in the original CAP will be updated as corrective actions are completed.
