SIGNIFICANT CHANGES FROM THE PREVIOUSLY ISSUED PERMIT

The permittee is responsible for carefully reading the permit in detail and becoming familiar with all of the changes therein:

1. PAA disinfection is replacing chlorine disinfection. An instantaneous maximum concentration and monitoring requirements for PAA have been added to the permit
2. A decimal place has been added to some limits to comply with the OWQ's updated rounding policy.
3. Monitoring frequency reduction language has been added to Part II of the permit.
4. Total Phosphorous and Nitrates plus Nitrites as Nitrogen monitoring and reporting requirements have been added to the permit.
5. Total Phenols monitoring requirements have been removed from the permit.
6. The WET dilution of 45% has been corrected to 42%.
7. The Schedule of Compliance has been removed.
8. The SSO language has been updated.
