Good morning Bailey,

The ongoing study is being performed as required by the CAO and a rehabilitation plan for the collection system will be provided by January 1, 2020. Considering the upgrades planned for the wastewater plant which may include a new location, increased capacity, etc. the rehabilitation plan for the collection system must take these things into account as well. Through efforts to date numerous sections of sewer collection main, manholes, and service leaks have been identified and upon completion of sewer televising a prioritized collection system rehabilitation plan will be developed and submitted as part of the study to be completed by Jan 1, 2020.

It is further my understanding based on the Revised CAO dated May 8, 2018 that final compliance shall be achieved by June 1, 2028.

We are requesting that the SSES Schedule be revised for a completion date being January 1, 2020.

I met with Mena Water yesterday and discussed the progress of the study to date and the remaining items. The major field review item that is ongoing is televising sewer mains which is being performed by Mena Water personnel. The mapping of the system has been thoroughly performed, smoke testing has been completed, and flow testing was performed. Given more information with the televising efforts we look to finalize the report and present a prioritized list of areas for rehab, etc.
