Bailey,

The City authorized Heller Construction to complete three (3) line replacements in the City. These areas were identified by the smoke testing as causing substantial I/I and are considered the Capital Improvement Projects.

Work should begin within a couple of weeks and be completed by June 1.

Regarding the sludge removal project –

The City has executed a Contract for the removal and the Contractor has secured the Land Application Permit from ADEQ.

However, considering the abnormal amount of rain received in the past few weeks, the land owner of the application site is concerned about irreparably damage to his property.

He is wanting to wait until June or July to begin the sludge removal and application project.

His position is likely justified.
