The Utility is continuing to make progress in competing the smoke testing and making service repairs. As previously reported, most of the service line leaks have been a result of missing caps. A summary of locations and repairs made is attached.


I presented budget numbers to the City Council on January 22 for the installation of an automatic chemical feed system at the WWTP to correct ph and alkalinity as a result of discharge from the WTP. The Council approved the budget and the preparation of plans and specifications for bid advertisement.

Additionally, The City Council was advised of budget numbers for professional sludge removal from the equalization basin at the WWTP. We plan to address removal in two phases. Phase I, which will address sludge removable by excavation, is advertised for bids with bid opening scheduled for Tuesday, January 30, 2018. Phase II will remove the remaining sludge volume from the basin and will be scheduled at a later date during dryer weather.

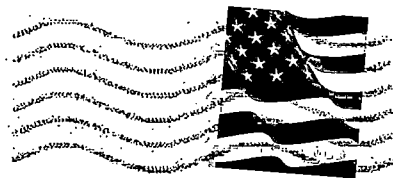
