We plan on correcting the problem in this manner:


We Have been taking water in from our equalization pond.

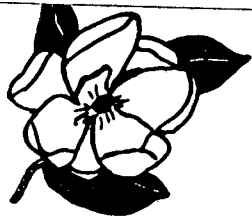

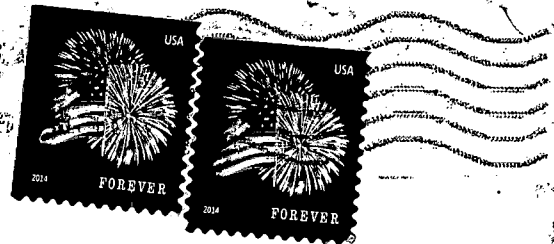
