Dear Mr. Cooper:

Enclosed is your signed copy of Consent Administrative Order (CAO) LIS 22-082. The Chief Administrator signed the Order on July 22, 2022. The Order will be sent for Public Notice on or about August 7, 2022. The effective date of the Order will be thirty (30) days after the Order has been sent for Public Notice, which will be September 6, 2022.

Per the Order and Agreement Section of CAO LIS 22-082, the Arkansas Department of Corrections - North Central Unit has agreed to:

- Submit a Corrective Action Plan (CAP) developed by a P.E. licensed in the state of Arkansas by **October 6, 2022**. The CAP should detail the actions that will be taken to come into compliance with the effluent limits of the permit and include a milestone schedule and final date of compliance.
- Submit quarterly progress reports detailing the actions taken to come into compliance with the effluent limits of the permit. The first progress will be due on **October 15, 2022** and quarterly thereafter until the CAO is closed.
- Submit a comprehensive Sanitary Sewer Flow Monitoring and Infiltration and Inflow (I/I) Study ("Study") developed by a Professional Engineer licensed in the state of Arkansas by **December 5**, **2022**. The Study shall include, at minimum, a baseline for sanitary sewer flows, rainfall monitoring, an estimate of available sewer capacity, identification of sources of I/I, an estimation of I/I, and a plan and milestone schedule for reducing III with a date of final compliance.
