As indicated in the October 23, 2018 quarterly progress report, the Contract for the sludge removal and disposal has been awarded. The Contractor has made permit application for the land application site to your office. Per the attached December 4, 2018 email from the Contractor, the land application permit is in the 30 day comment period and is expected to be approved by February 1, 2019. Considering this delay, the City is requesting a compliance date extension to July 1, 2019. Construction will begin immediately upon permit approval and is expected to be completed within 90 days, thereafter.

The Utility is continuing to make progress in completing the smoke testing and making service repairs. As previously reported, most of the service line leaks have been a result of missing caps.

The automatic chemical feed system at the waste water treatment plant is complete and operational. The Contract for the sludge removal and disposal has been awarded. The Contractor has made permit application for the land application site to your office. Construction will begin immediately upon permit approval. Pending permit receipt, which is beyond our control, the City may require a time extension to the CAP.
