This is to give notice that the Arkansas Department of Environmental Quality (ADEQ) Water Division, 5301 Northshore Drive, North Little Rock, Arkansas 72118-5317 at telephone number (501) 682-0648, proposes a draft renewal of the permit for which an application was received on July 23, 2014 which was revised due to a permit transfer and resubmitted on December 17, 2014 with additional information received on December 22, 2014; December 23, 2014; June 26, 2015; June 30, 2015; and July 6, 2015, for the following applicant under the Arkansas Water and Air Pollution Control Act.

Applicant: Benton County, Arkansas Suburban Sewer District No. 1 - Villages of Cross Creek Project, PO Box 9299, Fayetteville, AR 72703. Location: 2 miles east of I-540 in Rogers off Hwy. 62 on Dixieland Road;

Latitude: 36° 21' 52" N Longitude: 94° 8' 35" W.

This permit is for the operation of a decentralized waste water treatment system with drip irrigation dispersal for a residential apartment complex. This type of systems is also classified as Class V shallow injection wells under the provisions of APC&EC Regulation No. 17.

The facility is located in Stream Segment 3J of the Arkansas River Basin.

ADEQ's contact person for submitting written comments, requesting information regarding the draft permit, or obtaining a copy of the permit and the Statement of Basis is Sarah Cousins, at the above address and telephone number, or by email at Water-Draft-Permit-Comment@adeq.state.ar.us. For those with internet access, a copy of the proposed draft permit may be found on the ADEQ's website at www.adeq.state.ar.us.

The last day of the comment period is 30 days after the publication date at 4:30 P.M. Central Time. If the last day of the comment period is a Saturday, Sunday or legal holiday, the public comment period shall expire on the next day that is not a Saturday, Sunday or legal holiday. For information regarding the actual publication date along with the actual date and time the comment period will end, please contact Sarah Cousins at the above address and telephone number or by email at Water-Draft-Permit-Comment@adeq.state.ar.us. The staff member listed above may be contacted for the actual publication date and the exact date and time for the comment deadline. Comments and public hearing procedures may be found at Regulation No. 8 (Administrative Procedures). All persons, including the permittee, who wish to comment on ADEQ's draft decision to renew the permit, must submit written comments to ADEQ, along with their name and mailing address. After the public comment period, and public hearing, if one is held, ADEQ will issue a final permitting decision. A public hearing will be held when ADEQ finds a significant degree of public interest. ADEQ will notify the applicant and each person who has submitted written comments or requested notice of the final permitting decision. Any interested person who has submitted comments may appeal a final decision by ADEQ in accordance with the Regulation No. 8.
