A review of our records indicates that your permit will expire on **November 30, 2025**. In accordance with your current permit and state regulations, permittees wishing to continue operating subsequent to the expiration date of their permit are required to apply for a renewal permit not less than 180 days prior to the permit's expiration date.

**Due to the large number of renewal applications, a complete application must be received no later than 180 days prior to the expiration of your permit.** Any permit that expires without the receipt of a complete renewal application will no longer be valid. In such a case, a new permit application must be submitted. Operation of system past the expiration date of the permit will be unlawful and may be subject to formal enforcement action.

If our records are incorrect or if you need more time, please respond by letter to either the mailing address or email address above no later than **June 3, 2025**. If you do not desire to renew your permit, you must submit a termination request and closure plan (if applicable) to either the mailing address or email address above. Failure to submit the requested information could result in enforcement action.
