In accordance with Office of Water Quality (OWQ) policy, the application has been reviewed and determined to be administratively complete. The application has been assigned permit number 4815-WR-5. Pursuant to Act 163 of 1993, the public notice must be given for all permit applications submitted to the Division of Environmental Quality. On the reverse of this page is a public notice which will be published by OWQ in a local newspaper of general circulation for one (1) day. Arkansas Pollution Control and Ecology Commission (APC&EC) Regulation 8.205 requires the applicant to bear the expense and provide proof of payment for the publication. An invoice for the cost of publishing the public notice and proof of publication will be sent to you by the advertising newspaper. The permittee must send proof of publication and payment to the OWQ as soon as possible but no later than 30 days from the above date. Until the OWQ receives proof of publication of the public notice, no further action will be taken on the permit application.

Information on public notice requirements is included with this letter. You will continue to be invoiced for your annual fee as required by APC&EC Regulation No. 9.
