I would just like some clarification from you on 4890\_WR-2

In regards to the deficiencies the letter states that the NDSTW Form is incomplete. However the language I read in the NDSTW form I was given to use is as follows:

- The wastewater treatment plant (WWTP) must be examined by a Professional Engineer registered in the State of Arkansas to determine all necessary capital expenditures, system upgrades, or significant repairs which may be needed within the following five (5) years. ***A list of all of these items must be attached to this document.***
- A milestone schedule for completion of the capital expenditures, system upgrades, or significant repairs ***must be attached to this document.***

Am I missing something here? I do not see any wording relative to the deficiencies explanation under Part II Capital Expenditures. Is there a revised form that I do not have? I could not find anything under the forms on the ADEQ website

Regarding the deficiencies for Part III Financial Plan, I can get the number of bedrooms for the existing homes on the system. I included the projected build out in the table provided. Are you also

looking to have the number of bedrooms for the new homes in the future? That would be unrealistic to ask for in my opinion.
