An application for the renewal of a no-discharge permit was received on May 29, 2020, with additional information received June 4, 2020. In accordance with Arkansas Department of Energy and Environment - Division of Environmental Quality (DEQ), Office of Water Quality policy, the application has been reviewed and determined to be administratively complete. The application has been assigned permit number 4890-WR-3. Please refer to this number in any future correspondence concerning this application.

Pursuant to Act 163 of 1993, the public notice must be given for all permit applications submitted to DEQ. On the reverse of this letter is a public notice that will be published by DEQ in a local newspaper of general circulation for one (1) day. Arkansas Pollution Control and Ecology Commission (APC&EC) Rule 8.205 requires the applicant to bear the expense and provide proof of payment for the publication. An invoice for the cost of publishing the public notice and proof of publication will be sent to you by the advertising newspaper. The permittee <u>must send proof of publication and payment</u> to DEQ as soon as possible but no later than thirty (30) days from the above date. Until DEQ receives proof of publication of the public notice, no further action will be taken on the permit application.

Information on public notice requirements is included with this letter. You will continue to be invoiced for your annual fee as required by APC&EC Rule No. 9.
