This is to give notice that the Arkansas Department of Energy and Environment - Division of Environmental Quality (DEQ), Office of Water Quality, 5301 Northshore Drive, North Little Rock, Arkansas 72118-5317 at telephone number (501) 682-0650, proposes a draft renewal of the permit for which an application was received on May 29, 2020, with additional information received on June 4, 2020, for the following applicant under the Arkansas Water and Air Pollution Control Act. Applicant: Legacy Estates Utility LLC, PO Box 9299, Fayetteville, AR 72703. Location: south of Harmon Road and east and west of Strawberry Road; Latitude: 36 8 18 N Longitude: 94 17 12 W. This permit is for the operation of a decentralized waste water treatment system with drip irrigation dispersal for a residential subdivision. This type of systems is also classified as Class V shallow injection wells under the provisions of APC&EC Rule 17.

The facility is located in Stream Segment 3J of the Arkansas River Basin.

All persons, including the permittee, who wish to comment on DEQ's draft decision to renew the permit, must submit written comments to DEQ, along with their name and mailing address. After the public comment period, and public hearing, if one is held, DEQ will issue a final permitting decision. A public hearing will be held when DEQ finds a significant degree of public interest. DEQ will notify the applicant and each person who has submitted written comments or requested notice of the final permitting decision.
