Dear Honorable Lee:

Please be advised that the above referenced permit will expire on **November 30, 2023**. To date, our records show that you have not reapplied for the renewal permit. We are aware that you still have time in which to submit a renewal application. However, in order to continue operating after the expiration date of the existing permit, a **complete** renewal application must be received by the Office of Water Quality no later than **June 3, 2023**.

Please be advised, the subject permit is no longer valid after the expiration date. If a complete renewal application or request for an extension is not received by **June 3, 2023**, this will be in violation of your current permit and state regulations.

If our records are incorrect, or if you do not desire to renew your permit, please respond by letter as soon as possible. If you need more time to submit the renewal application, please submit your request in writing to the Director of the Division of Environmental Quality prior to **June 3, 2023**.
