On behalf of the City of Cave Springs, Arkansas, McClelland Consulting Engineers, Inc. (MCE) hereby requests an additional extension for addressing the public comments which were received during the public comment period for renewal of existing WWTP drip irrigation No-Discharge Permit, Permit No.: 4893-WR-3.

The major request for alteration was made in order to get Package Treatment Plant #1 back online, in order to ensure that wastewater treatment needs of the city will be met for the upcoming permitting cycle. MCE was working closely with the new utility director in order to get the treatment plant back online. Unfortunately, Mr. Tyler left his position with the city shortly after permit alterations were requested.

In order to get treatment plant #1 back online, coordination with a city official in charge of wastewater operations will be required. As the city transitions into having a new employee in such a position, additional time is needed in order to achieve this goal. The water and wastewater team here at MCE is dedicated to serving the community of Cave Springs with quality service and due diligence, therefore, this situation is of high priority to MCE. Due to the referenced unforeseen issues, an extension of 60 days is requested, although every attempt will be made to have this completed as soon as possible.
