Based on our meeting at the ADEQ Little Rock office on Tuesday, May 18<sup>th</sup>, Mr. Carter and I have determined that in order to fulfill the requests made for the renewal of Cave Springs' No-Discharge Permit; we will need an additional deadline extension.


One of the requests made was to get a depth to ground water, but due to the recent immense amount of rainfall, getting our boring equipment onto the course will cause severe damage to the grounds of the Creeks Golf Course, and therefore it will be necessary to wait for the course to dry out before boring can occur.

Extenuating circumstances will delay submittal of permit information, therefore, we are asking for an additional extension of two weeks. The proposed extension would push the due date of all requisite documentation to Monday, May 15<sup>th</sup>. All possible attempts will be made to complete the renewal process prior to the proposed extension deadline.
