



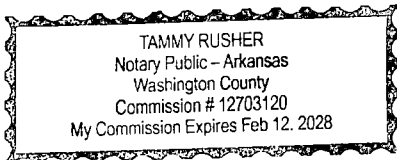

This is to give notice that the Arkansas Department of Environmental Quality (ADEQ) Office of Water Quality, 5301 Northshore Drive, North Little Rock, Arkansas 72118-5317 at telephone number (501) 682-0650, proposes a draft renewal of the permit for which an application was received on May 2, 2018, with additional information received on August 10, 2018, for the following applicant under the Arkansas Water and Air Pollution Control Act. Applicant: Cane Island Estates, LLC, 39 Nottingham Lane, Rogers, AR 72758. Location: Located along the White River on the west side of CR 7002 in northern Marion County.; Latitude: 36 20 39 N Longitude: 92 33 34 W.

This permit is for the operation of a decentralized waste water treatment system with drip irrigation dispersal for a residential subdivision. This type of systems is also classified as Class V shallow injection wells under the provisions of APC&EC Regulation No. 17.

The facility is located in Stream Segment 41 of the White River Basin. All persons, including the permittee, who wish to comment on ADEQ's draft decision to renew the permit, must submit written comments to ADEQ, along with their name and mailing address. After the public comment period, and public hearing, if one is held, ADEQ will issue a final permitting

decision. A public hearing will be held when ADEQ finds a significant degree of public interest. ADEQ will notify the applicant and each person who has submitted written comments or requested notice of the final permitting decision. Any interested person who has submitted comments may appeal a final decision by ADEQ in accordance with the Regulation No. 8.
