Dear Mr. Cook:

Please be advised that No-Discharge Permit No. 4908-WR-1 expired on 7/31/2017. Pursuant to Condition 23 of Part III of your current permit, a complete permit application shall be submitted 180-days before the expiration date. Since the permit application was not submitted prior to this date, your existing permit will not be valid after the expiration date.

In accordance with Department policy, your application has been reviewed and determined to be administratively complete. For recordkeeping purposes, the first four digits of your permit number will remain the same. Please refer to permit number 4908-WR-2 in any future correspondence concerning this application.

Pursuant to Act 163 of 1993 the public notice must be given for all permit applications submitted to this Department. On the reverse of this letter is a public notice, deemed acceptable to this Department, which is to be published by the Department in a local newspaper of general circulation for one (1) day only. Regulation 8, 2.1.4 (c) requires the applicant to bear the expense of the notice's publication and provide proof of payment of the publication. An invoice for the cost of publishing the public notice and proof of publication will be sent to you by the advertising newspaper. The permittee must send proof of publication and payment to the Department as soon as possible but no later than 30 days from the above date. Until this Department receives proof of publication of the public notice, no further action will be taken on the permit application.

Information on public notice requirements is included with this letter. Additionally, a permit fee is required by Act 817 of 1983, as amended, and Act 1254 of 1993, as amended and Regulation No. 9. Your fee will be in accordance with the fee schedule contained in Section 7 of Regulation No. 9 and an invoice will be sent to you.
