The C&H Regulation 5 permit application is determined to be administratively complete and therefore an Application Public Notice will be published in the New County Times on Wednesday May 25, 2016. During this 10-day public notice, interested persons may request a public hearing on the application.

> Once the technical review is complete, the Department will propose a draft permit that will be public
noticed for a 30-day comment period in New County Times. Interested persons may submit their
comments with regard to the proposed draft permit during the 30-day comment period. You may refer
