Dear Ms M'Williams

This response to the letting of permit 5264-W concerning C and H Hog Farms, Inc., located in Newton County, is not intended to address the many scientifically based research issues which have been accumulated by various qualified experts. My address is morally and politically oriented.

The first point I make is simply why should an infinitely small percentage of people have the "right" to influence and basically force the vast majority of the populace to except thier premise of thier "right" to dominate public opinion. Basically freedom is tethered to many and varied responsibilities which include sound husbandry of the land and public safety. Why should the Campbells and Hensons be

allowed to contaminate large areas of the surrounding private and public lands by their desire to enrich themselves by forcing everyone else to conform to their point of view.
