Subject: EDCC

As a follow up to your discussion with John Carver during the pipeline public meeting, I called Pat to schedule a meeting as you suggested. This is to confirm our meeting for Monday, June 12 at 8:30 am.

The following are the outstanding items that need further discussion and (hopefully) some resolution (with suggestions as to which staff members may need to be present to discuss the issues).

1. Re-routing the sanitary sewer to Lake Kildeer to provide a carbon source, enhance the biological treatment and accelerate EDCC's ability to meet the new permit limits. If approved, the sanitary sewer limits would still apply, and the receiving stream would not change. This is a high priority item, due to the permit compliance deadline and the need for a carbon source. (Martin Maner, Mo Shafii) *will submit a comment*
2. Groundwater CAO and interim measures. EDCC had agreed with Laura Stuart-Leslie to install recovery wells in lieu of the bioremediation, and has scheduled drillers to begin work. The last draft of the CAO we received from ADEQ still had the bioremediation in the order (which I assume was in error). This needs to be resolved so EDCC can proceed with the recovery wells if that is still ADEQ's desire. We should be able to finalize the CAO. (Dawn Guthrie and Laura Stuart-Leslie). *check with Laura*
- ✓ 3. NPDES amendment to implement the temperature study. We believe that ADEQ now has all the info required. (Martin Maner and Mo Shafii) *submit a comment*
4. Extension of compliance schedule for water quality based effluent limits. This is an item that needs some resolution. After our last meeting you mentioned that the Staff would do an inspection to see what progress had been made before further discussions would be held. That inspection has occurred. (Martin Maner)
