Please accept this letter as the annual report of BMP activities as required by Part II, Condition No. 9 of the above referenced NPDES Permit consistent with the Department's July 23, 2020 letter to Georgia-Pacific Crossett LLC (GP). As previously communicated to the agency on October 4, 2019, the facility permanently shut down its Kraft pulping operations. As such, the requirements of 40 CFR 430.03 are no longer applicable to this facility. The new operating footprint has been communicated to the agency as part of the NPDES renewal process. At this time, the current permit has been administratively continued and therefore the BMP requirement cannot be removed from the permit. Until the renewal permit is issued, GP will continue to provide any pertinent updates to the agency.

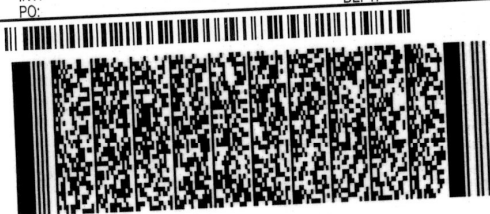

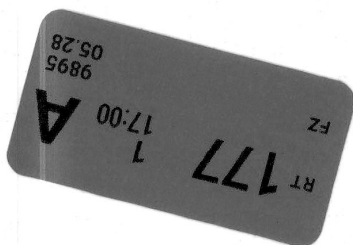
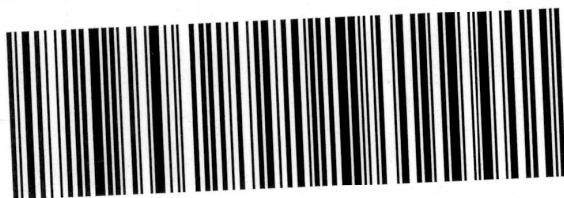
