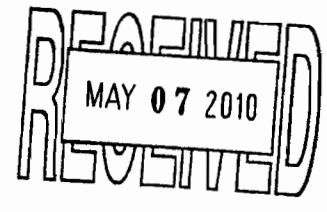
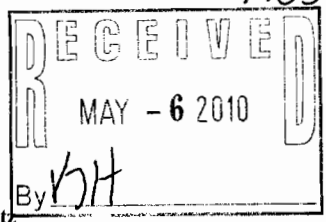

On motion by Shane Hart, seconded by Billy Ellis and unanimously approved at the regular board meeting of Caldwell Parish Farm Bureau on 3/4/2010.

WHEREAS the Ouachita River is Caldwell Parish's and Northeast Louisiana's greatest asset toward future recreation, tourism and economic growth. The Ouachita River will also become the source of most of our drinking water in the future.

WHEREAS the majority of the Ouachita River's water in Arkansas is clear and free of pollution. Now, we the people of Northeast Louisiana are asking for a river with clear, less polluted water.

THEREFORE, the Caldwell Parish Farm Bureau does hereby ask the Arkansas Environmental Protection Agency to deny the Georgia Pacific Mill at Camden Arkansas a permit to dump hazardous waste that darkens and pollutes the water of the Ouachita River.
