PUBLIC NOTICE OF PUBLIC MEETING AND HEARING FOR  
DRAFT RENEWAL NPDES DISCHARGE PERMIT NUMBER AR0001210

The Arkansas Department of Environmental Quality (ADEQ) will hold a public meeting and hearing May 10, 2010, in Crossett to accept comments on the draft renewal of the permit for Georgia-Pacific LLC - Crossett Paper Operations, 100 Mill Supply Road, Crossett, AR 71635. Location: west on Hwy 82 from the paper mill, go 1 mile before turning left onto Texas Ave. Go 2 miles then turn right. Proceed until you come to a T in the road, noting where the primary clarifier is located; Latitude: 33° 08' 30"; Longitude: 91° 58' 12" in Ashley County, Arkansas.

The hearing will begin at 6:00 p.m. at the Crossett Middle School, 100 Petersburg Road, in Crossett.

The purpose of the public hearing is to allow public participation in the determination of the terms and conditions of the renewal of the draft NPDES permit. ADEQ technical staff will be available to informally discuss the draft permit. In addition, a hearing officer will accept formal public comments at the hearing. Verbal comments will be accepted, but written comments are preferred in the interest of accuracy.

All oral or written comments submitted during the public hearing will be considered by the ADEQ in its decision-making process involving the permit renewal, and the public comment period will close when the hearing adjourns. Written comments at the hearing are preferred, in the interest of accuracy.
