THIS IS A MODIFIED PERMIT. IN ACCORDANCE WITH 40 CFR 122.62, ONLY THE CONDITIONS WHICH ARE THE SUBJECT OF MODIFICATION COMMENTS REOPENED. CONCERNING ANY PORTIONS OF THE PERMIT WHICH HAVE NOT BEEN REOPENED WILL NOT BE CONSIDERED. The pH monitoring frequencies at Outfall 001 and SMS002 have been changed to three times per week. Conditions #16 and #17 of Part II of the permit have been deleted. As a result, Conditions #18 - #22 have been renumbered. 3. The Mercury Minimization Plan requirements have been revised. A Public Hearing will be held when ADEQ finds a significant degree of public interest. ADEQ will notify the applicant and each person who has submitted written comments or requested notice of the final permitting decision.
