Authorization for Treatment of Wastewater from Georgia-Pacific Taylorsville

Dear Ms. Reiber:

Georgia-Pacific's Crossett Paper Operations would like to request authorization from ADEQ to accept excess wash water/storm water from the Georgia-Pacific Taylorsville, MS chemical plant. The water needing disposal is a combination of process area wash water (which comes from general area wash-up and wash-up of area equipment) and storm water that falls on the process area that is potentially contaminated. All the water drains to a common sump and is universally referred to as "wash water". All of this water is typically recycled for reuse in the process, but due to the recent heavy rains the current volume is more than can be reused in the process. The plant has a 70,000 gallon wash water storage tank, with a current level of approximately 85% due to recent water usage and excess rainfall. In anticipation of more rainfall and possible production shutdowns, the plant would like to lower the tank volume to a more manageable level.

This water is characteristically like identical wastewaters currently being discharged to the treatment system by the chemical plant located within the Crossett Complex. A Certificate of Analysis for this wastewater has been attached for your review.

Upon receiving agency approval the plant would like to immediately ship 6 approximately 5,500 gallon loads (for a total of 33,000 gallons) to Crossett Paper Operations' wastewater treatment system within the week following ADEQ approval. Depending on weather conditions, we may need to send additional volume over the next few weeks as weather and production conditions require. We will provide notification to you of any additional volumes required for disposal on a weekly basis prior to shipping should the need arise.
