Section 8-4-230(a)(1)(A), that the Director of the Arkansas Department of Environmental Quality (ADEQ), 5301 Northshore Drive, North Little Rock, AR 72118-5317, phone number (501) 682-0618, has granted a Temporary Variance to Georgia Pacific, Crossett LLC Crossett Paper Operations, 100 Mill Supply Road, Crossett, AR 71613. The facility is hereby authorized to begin trial operations to assess the potential to reduce the generation of sulfides in the mill wastewater treatment system. The request was received on June 28, 2017. The proposed trial operations will occur at 100 Mill Supply Road, Crossett, AR 71613. This decision is subject to and contingent upon the right of the public to object to the Director's decision. Any member of the public may object to the Director's decision or request a public hearing within ten (10) business days of the date of this notice. Objections or requests for a public hearing will be accepted if submitted no later than 4:30 pm on the last day of the comment period. 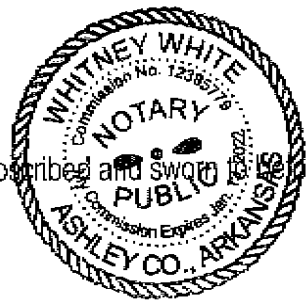
