Dear Mayor Halbrook:

The application for renewal of your expiring NPDES permit was received on May 4, 2020, with all additional information received by May 16, 2020. In accordance with Division policy, your application has been reviewed and determined to be administratively complete on May 16, 2020.

All permits are issued in accordance with federal and state priorities for water pollution abatement. Therefore, it is possible that the processing of this application for permit renewal may take some time depending on the relative priority of the discharge in comparison with others. However, every effort will be made to expedite the processing of your permit.

Since an administratively complete renewal application was not received by the Division at least 180 days prior to the expiration date of your current permit as required in 40 CFR 122.21(d) and APC&EC Regulation 6.201, be advised that permit coverage will lapse if a new permit is not issued and effective by the expiration date. Missing the 180 day deadline exposes the facility to enforcement action.

Pursuant to Act 163 of 1993 and Arkansas Pollution Control and Ecology Commission (APC&EC) Regulation No. 8, Section 8.205, public notice must be given for all permit applications submitted to this Division. The enclosed public notice will be published by <u>DEQ</u> in a newspaper of general circulation for one (1) day only. An invoice for the cost of publishing the public notice and proof of publication will be sent to you by the advertising newspaper. The permittee <u>must</u> send proof of publication and payment to the address at the bottom of this letter as soon as possible but no later than 30 days from the above date. Until this Division receives proof of publication of the public notice, no further action will be taken on the renewal of your discharge permit.
