The application has been deemed administratively complete and is undergoing technical review by the Office of Water Quality for compliance with State and Federal regulations. The facility under consideration is located as follows: 340 Westwood Ave., Mountain View, in Stone County, Arkansas.

Proposed Construction will include rehabilitation of the existing headworks basket screen, oxidation ditch, final clarifier, and UV disinfection system. In addition, a redundant final

clarifier, along with installation of launder covers on the existing clarifier, and UV channel covers on the UV structure is planned for construction. The existing treatment system is screening, oxidation ditch, secondary clarifier, and UV disinfection. The design flow is being increased from 0.73 MGD to 0.95 MGD.
