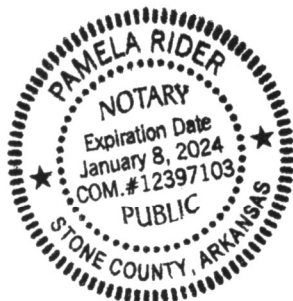

This is to give notice that the Arkansas Department of Environmental Quality (ADEQ), Water Division, 5301 Northshore Drive, North Little Rock, Arkansas 72118-5317 at telephone number (501) 682-0623, proposes a draft construction permit for which an application was received on April 22, 2015 with additional information received on May 4, 2015 in accordance with Regulation No. 6.

Applicant: City of Mountain View, 340 Westwood Ave., Mountain View, AR 72560, turn north onto Westwood Avenue from Highway 66 and travel approximately 0.25 miles; Latitude: 35° 51' 59.48"; Longitude: 92° 08' 53.83" in Stone County, Arkansas.

The discharge from this existing facility is made into Hughes Creek, then to Lick Fork Creek, then to South Sylamore Creek, then to the White River in Segment 4F of the White River Basin.

Proposed construction will include converting an anaerobic digestion chamber to an aerobic digestion chamber with a design flow of 0.75 MGD. Modification of the NPDES discharge

permit is not required.

ADEQ's contact person for submitting written comments, requesting information regarding the draft permit, or obtaining a copy of the permit and the Statement of Basis is Eleanor Goins, at the above address and telephone number or by email at Water-Draft-Permit-Comment@adeq.state.ar.us. The comment period shall end at 4:30 P.M. (Central Time) on the 30th day after the publication date. If the last day of the comment period is a Saturday, Sunday, or legal holiday, the public comment period shall expire on the next day that is not a Saturday, Sunday, or legal holiday. For information regarding the actual publication date along with the actual date and time the comment period will end, please contact Eleanor Goins at the above address and telephone number or by email at Water-Draft-Permit-Comment@adeq.state.ar.us. Public notice, comments, and hearings will be conducted in accordance with Regulation 8.209 and 8.210 (Administrative Procedures). All persons, including the permittee, who wish to comment on ADEQ's draft permitting decision must submit written comments to ADEQ, along with their name and mailing address. A Public Hearing will be held when ADEQ finds a significant degree of public interest. After the public comment period, ADEQ will issue a final permitting decision. ADEQ will notify the applicant and each person who has submitted written comments or request notice of the final permitting decision. Any interested person who has submitted comments may appeal a final decision by ADEQ in accordance with the APCEC Regulation No. 8.603.

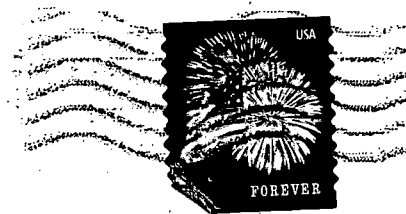
