In accordance with Ark. Code Ann. § 8-4-203(e), the Arkansas Department of Energy and Environment – Division of Environmental Quality (DEQ), Office of Water Quality, gives the following notice:

The City of Mountain View -Mountain View Wastewater Treatment Plant operates a facility located as follows: 340 Westwood Ave., Mountain View, AR 72560 in Stone County. The facility is currently permitted to discharge treated municipal wastewater into Hughes Creek, thence to Tubbs Creek, thence to Lick Fork Creek, thence to south Sylamore Creek, thence to the White River in Segment 4F of the White River Basin. The City of Mountain View - Mountain View Wastewater Treatment Plant submitted an application on May 17, 2021, with all additional Information received by May 28, 2021, for the major modification of NPDES Permit No. AR0020117 and state construction permit No. AR0020117C. The application has been reviewed by the DEO's Office of Water Quality and has received tentative approval subject to the terms of this notice.

Proposed Construction will in-Clude rehabilitation of the existing headworks basket screen, oxidation ditch, final clarifier, and UV disinfection system. In addition, a redundant final clarifier, along with installation of launder covers on the existing clarifier, and UV channel covers on the UV structure is planned for construction. The existing treatment system is screening, oxidation ditch, secondary clarifier, and UV disinfection. The design flow is being increased from 0.73 MGD to 0.95 MGD.

The 208 Plan, developed by the DEQ under provisions of Section 208 of the federal Clean Water Act, is a comprehensive program to work toward achieving federal water goals in Arknass. The initial 208 Plan, adopted in 1979, provides for annual updates, but can be revised more often if necessary. Updates to the 208 Plan have been proposed to revise the design flow from 0.73 MGD to 0.95 MGD, and revise the monthly average artmonia limit for November through March from 10.0 mg/L to 8.0 mg/L for months of November through April... These changes have also been incorporated into the draft discharge permit Citizens wishing to examine or obtain copies of the permit application, the draft permitting decision, the Statement of Basises or the 208 Plan may do so at the DEQ headquarters located at 5301 Northshore Drive, North Little Rock, AR 72118-5317. A Public Hearing will be held when DEQ finds a significant degree of public interest. After the public comment period, DEQ will issue a final permitting decision. DEQ will notify the applicant and each person who has submitted written comments or requested notice of the final permitting decision. Any interested person who has submitted comments may appeal a final decision by DEQ in accordance with the APC&EC Rule 8.
