1st D.O. Progress Report

Mo,

Sorry for the delay in responding to your earlier email. With regards to the DO and Mercury report that you identified as being due in May. It is Cooper's understanding that, with the acceptance of the PAR in November, the 2009 permit is void. Consequently, Cooper was not required to provide a report or perform any additional testing. In the meantime Cooper has sampled its discharge in accordance to the DMRs that it was sent.

This appears to affect Mercury most since the PAR specifies that all references to Mercury are to be removed from the permit and it is not listed on the DMRs. However, Cooper has been conducting DO tests and has been submitting this data per the DMRs. You will find a summary of the data that has been submitted below. As you will see all tests have shown the water to be in compliance with the DO limit as it would have been in the 2009 permit.
