The 208 Plan, developed by the DEO under provisions of Section 208 of the federal Clean Water Act, is a comprehensive program to work toward achieving federal water goals in Arkansas. The initial 208 Plan, adopted in 1979, provides for annual updates, but can be revised more often if necessary. Updates to the 208 Plan have been proposed to change the facility flow at Outfall 003 from 3.36 MGD to 6.45 MGD. This change has also been incorporated into the draft discharge permit.
