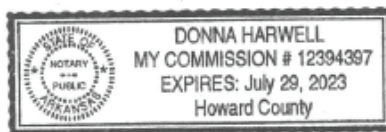

Boone County case of Avian Influenza sparks concern statewide

The Arkansas Livestock and Poultry Commission is currently investigating a case of Avian Influenza at a Boone County poultry farm. The farm has been placed under quarantine. The flock was positive on testing for H5N2 Avian Influenza.

The potential losses and costs associated with Avian Influenza outbreaks make it extremely important for the poultry producer and small poultry flock owner to protect their flocks against AI and other diseases by using Biosecurity practices such as those listed below:

1. Keep “No Visitors” and/or “Restricted” signs posted at the road entrance of the farm.
2. Do not allow visitors on the farm or in the poultry houses.
3. All farm personnel should wear separate clothing (including shoes, boots, hats, gloves, etc.) on the farm. Clothes used on the farm should stay on the farm.
4. Completely change all clothing after caring for the flock, and wash hands and arms thoroughly before leaving the premises.
5. Do not visit other poultry farms or flocks or have contact with any other species of birds.
6. Keep all poultry houses securely locked. Lock all houses from the inside while working inside.
7. All equipment, crates, coops, etc. should be thoroughly cleaned and disinfected before and after use.
8. All essential visitors (owners, feed delivery personnel, poultry catchers and haulers, servicemen, etc.) are to wear protective outer clothing (coveralls), boots, and headgear prior to being allowed near the poultry flock or farm.

9. Monitor all vehicles (service, feed delivery, poultry delivery or removal, etc.) entering the premises to determine if they have been properly cleaned and disinfected. This includes disinfection of the tires and vehicle undercarriage.
10. Sick and dying birds should be submitted to a diagnostic laboratory for proper diagnosis of the problem. All commercial growers should contact their flock supervisor and follow their instructions.
11. Dead birds are to be properly disposed of by burial, incineration or other approved method.
12. Any person handling wild game (especially waterfowl) must completely change clothing and shower or bathe before entering the premises.
13. Do not borrow equipment, vehicles, etc. from another poultry farm.
14. Do not visit areas where avian influenza is a problem.
15. Remember to use basic hygiene to prevent contracting any influenza virus. This includes covering your mouth when you cough and/or sneeze and then washing your hands with soap and water afterwards.
16. Properly handle and cook all poultry for consumption to an internal temperature of at least 165 degrees Fahrenheit.

Pike County Man arrested after chase

A man from Pike County is in custody there after allegedly threatening his wife with a firearm and discharging that firearm, then leading police on a chase through Sevier County.

Jeremy Jewell, 39, was reported as having pointed a gun at his wife's head after the two were involved in an altercation in their home Tuesday evening,

then firing the weapon into the air, according to statements made by prosecuting attorney Bryan Chesshir to media. Jewell reportedly then left the home.

A search for Jewell in several counties eventually led to his vehicle being identified around 6 p.m. along Highway 71 in Sevier County, according to police sources. Jewell, in the vehicle,

allegedly then led members of local law enforcement as well as the Arkansas State Police on a chase through Sevier County which ended in a wreck about 6:30 p.m. between De Queen and Gillham.

In connection with the chase and wreck, another vehicle was struck by a Sevier County sheriff's department cruiser. A

female victim of the crash was reportedly transported to a Texarkana area hospital for treatment of injuries sustained in the accident, though her name and condition have not been released, nor has the name of the deputy driving the police vehicle which collided with her vehicle.

Jewell is being held in the Pike County Detention Center.

This is to give notice that the Arkansas Department of Environmental Quality (ADEQ), Water Division, 5301 Northshore Drive, North Little Rock, Arkansas 72118-5317 at telephone number (501) 682-0622, proposes a draft renewal of the permit number AR0043125 for which an application was received on 4/25/2014 for the following applicant under the National Pollutant Discharge Elimination System (NPDES) and the Arkansas Water and Air Pollution Control Act. Applicant: City of Norman, 535 Village Avenue, Norman, AR 71960. Location: approximately 1/2 mile east of the intersection of State Highways 8 and 27; Latitude: 34° 26' 42.35"; Longitude: 93° 40' 25.48" in Montgomery County, Arkansas. The discharge of treated municipal wastewater is into the Caddo River, thence to DeGray Lake, thence to the Ouachita River in Segment 2F of the Ouachita River Basin.

If the last day of the comment period is a Saturday, Sunday or legal holiday, the public comment period shall expire on the next day that is not a Saturday, Sunday or legal holiday. Public notice, comments, and hearings will be conducted in accordance with Regulation 6.104(A)(5) [40 CFR Parts 124.10 through 124.12 by reference] and Regulation 8.209 and 8.210 (Administrative Procedures). All persons, including the permittee, who wish to comment on ADEQ's draft permitting decision must submit written comments to ADEQ, along with their name and mailing address. A Public Hearing will be held when ADEQ finds a significant degree of public interest. After the public comment period, ADEQ will issue a final permitting decision. ADEQ will notify the applicant and each person who has submitted written comments or requested notice of the final permitting decision. Any interested person who has submitted comments may appeal a final decision by ADEQ in accordance with the APCEC Regulation No. 8.603.
