I am working on a renewal of this permit. Please find attached DMR data for the last three years. A review of this information showed the following violations of effluent limitations during the listed below monitoring periods:

Fecal Coliform Bacteria - May 2007, October 2009, November 2009, January 2010, and April 2010.

Ammonia Nitrogen - August 2008 and January 2010.

Dissolved Oxygen - August 2009, April 2010, June 2010, and July 2010.

Total Suspended Solids - January 2010, February 2010, April 2010, and May 2010.

Additionally, there were several DMRs showing as "not received"

Is this facility under CAO/NOV? Are there any other enforcement issues I need to be aware of while drafting this permit?
