The application for an NPDES permit was received on 12/14/2009. In accordance with Department policy, the application has been reviewed and determined to be administratively complete. The application has been assigned NPDES permit number AR0051454. Please refer to this number in any future correspondence concerning this application.

All permits are issued in accordance with federal and state priorities for water pollution abatement. Therefore, it is possible that the processing of this application for permit renewal may take some time depending on the relative priority of the discharge in comparison with others. However, every effort will be made to expedite the processing of your permit.

Pursuant to Act 163 of 1993 and Arkansas Pollution Control and Ecology Commission (APCEC) Regulation No. 8, Section 8.205, public notice must be given for all permit applications submitted to this Department. The enclosed public notice will be published by <u>ADEQ</u> in a newspaper of general circulation for one (1) day only. An invoice for the cost of publishing the public notice and proof of publication will be sent to you by the advertising newspaper. The permittee <u>must</u> send proof of publication and payment to the following address as soon as possible but no later than 30 days from the above date. Until this Department receives proof of publication of the public notice, no further action will be taken on the renewal of your discharge permit.
