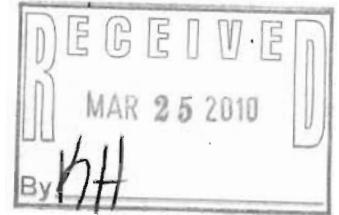

PUBLIC NOTICE OF DRAFT PERMIT FOR STORMWATER DISCHARGES FROM INDUSTRIAL ACTIVITIES

PERMIT NUMBER AR0061466, AFIN 60-01509

This is to give notice that the Permits Branch of the Water Division of the Arkansas Department of Environmental Quality (ADEQ), 5301 Northshore Drive, North Little Rock, Arkansas 72118-5317 at telephone number (501) 682-0622, proposes a draft issuance of the permit for the stormwater discharges from an industrial activity for which an application was received on 12/14/2009 with additional information received 12/29/2009 for the following applicant, under the National Pollutant Discharge Elimination System (NPDES) and the Arkansas Water and Air Pollution Control Act. Applicant: Caterpillar Inc., North American Water Cluster, Facility # 6201, Faulkner Lake Road, North Little Rock, AR 72117, Location: 9201 Faulkner Lake Road, North Little Rock, AR 72117; Latitude: 34° 44' 51.64"; Longitude: 90° 9' 36.05" in Pulaski County, Arkansas. The discharges of stormwater are into an unlined ditch, thence into Faulkner Lake, thence into Plum Bayou, thence into the Arkansas River in Segment 6C of the Arkansas River Basin.

ADEQ's contact person for submitting written comments, requesting information regarding the draft permit, or obtaining copy of the permit and the Statement of Basis is Jennifer Hampton, at the above address and telephone number, or by e-mail at Water-Draft-Permit-Comment@adeq.state.ar.us. For those with internet access, a copy of the proposed draft permit may be found on the ADEQ's website at <http://www.adeq.state.ar.us/permit> can permit individual comments on the draft permit issue.

The last day of the comment period is 30 days after the publication date. If the last day of the comment period is a Saturday, Sunday or legal holiday, the public comment period shall expire on the next day that is not a Saturday, Sunday or legal holiday. The permit will become effective approximately two weeks after the close of the comment period unless comments are received and/or a public hearing is requested prior to the close of the comment period requiring a delay of the effective date.

Comments and public hearing procedures may be found at 40 CFR Parts 124.10 through 124.32 and APCEC Regulation No. 3. All persons, including the permittee, who wish to comment on ADEQ's draft permitting decision must submit written comments to ADEQ, along with their name and mailing address. After the public comment period and public hearing, if one is held, ADEQ will issue a final permitting decision. A Public Hearing will be held when ADEQ finds a significant degree of public interest. ADEQ will notify the applicant and each person who has submitted written comments of its requested copies of the final permitting decision. Any interested person who has submitted comments may appeal a final decision by ADEQ in accordance with the APCEC Regulation No. 8 Administrative Procedures, 60167079.
