I am requesting that ADEE/ADEQ currently deny this permit and we need a public hearing on Permit No discharge permit AR0053210, AFIN 60-05010. This is my argument:

1. Mr. Rick Ferguson's reasoning that "raw sewage escaping septic tanks during flooding is much worse", on channel 7 report, Wednesday, November 3rd 2021, indicates to me how he is planning for many more of these city type housing expansions in this area.. Therefore, the waste water discharge, stated in his application, into the small creek with slow natural flow into Mill Bayou will substantially increase in time beyond natural flow. His foot is in the door, so he can make a great profit. Mr. Ferguson knows he will have no responsibility for the damages done down the road by his very poor planning for the future of Roland AR and other areas. <u>Only the people in Roland's area can have this responsibility</u>.

2. The amount of waste water discharging into the small creek, by my estimate, using Act 96 tables, will probably exceed 8 million gallons per year for this small 76 tract home development. THIS IS, **at the outset**, EXCESSIVE hydrologic intrusion on the Roland people's property, who live in this area with private property which they labored for and have pride to maintain in its natural beauty as citizens of our state. His foot is in the door.

3. The ADEQ is requested to <u>require</u> responsible development OF THIS AREA, and this <u>must be approved</u> by the landowners who are responsible for this area. And it follows that all developers who are approved by the people to build subdivisions should be required to have an approved long term plan. The development of our land out here is and always has been, by nature, small land areas owned by individuals with their own septic systems. The intrusion by any developer to build a city type neighborhood out here must not be allowed and not be approved to pour unnatural effluents near people's properties which will encroach the air we breathe and the animals and scenery we have here. He has his foot in the door.
