PUBLIC NOTICE OF REVISED DRAFT DISCHARGE PERMIT AND 208 PLAN PERMIT NUMBER AR0053210, AFIN 60-05010

This is a revised draft permit and re-publication of the draft for public comment. The public notice for the original draft permit was previously published on July 11, 2021, and the public comment period ended on August 11, 2021. The second draft permit was public noticed on March 6, 2022. Numerous comments and requests for a public hearing were received before the public comment period ended on April 4, 2022. A public hearing was public noticed on April 17, 2022, and subsequently held on May 18, 2022.

Based on the revised information submitted by the consultant, the draft permit will be re-published. In addition to a change in the cost of construction estimate, Part II.10 has been added to the permit and an updated disclosure statement was submitted.

It is important to note that all comments received to date will be responded to when a final permitting decision has been made. Resubmitting comments made during a previous public notice comment period is unnecessary.

In accordance with Ark. Code Ann. § 8-4-203(e), the Arkansas Department of Energy and Environment – Division of Environmental Quality (DEQ), Office of Water Quality, gives the following notice:

Pulaski County Property Owners' Multipurpose Improvement District No. 2021-2 will operate the Paradise Valley Subdivision WWTP facility located as follows: Roland Cutoff, Roland, AR 72135 in Pulaski County. This is a new facility that is proposing to discharge treated domestic wastewater into an unnamed tributary of Mill Bayou, thence to Mill Bayou, thence to the Arkansas River in Segment 3C of the Arkansas River Basin. Pulaski County Property Owners' Multipurpose Improvement District No. 2021-2 - Paradise Valley Subdivision WWTP submitted an application on September 2, 2020, with all additional information received by October 17, 2022, for the issuance of NPDES Permit No. AR0053210. The application has been reviewed by the DEQ's Office of Water Quality and has received tentative approval subject to the terms of this notice.

The 208 Plan, developed by the DEQ under provisions of Section 208 of the federal Clean Water Act, is a comprehensive program to work toward achieving federal water goals in Arkansas. The initial 208 Plan, adopted in 1979, provides for annual updates, but can be revised more often if necessary. Updates to the 208 Plan have been proposed to add this new facility with the following water quality limitations. These updates have also been incorporated into the draft discharge permit.

All persons, including the permittee, who wish to comment on DEQ's draft permitting decision must submit written comments to DEQ, along with their name and mailing address. A Public Hearing will be held when DEQ finds a significant degree of public interest. After the public comment period, DEQ will issue a final permitting decision. DEQ will notify the applicant and each person who has submitted written comments or requested notice of the final permitting decision. Any interested person who has submitted comments may appeal a final decision by DEQ in accordance with the APC&EC Rule 8.
