The facility proposes to discharge treated process wastewater through outfall EV201, and discharge stormwater runoff, dust suppression water, and quenching water from slag yard through Outfall EV202 into the Mississippi River Basin. Exploratory Ventures, LLC submitted an application on November 9, 2022, with additional information received by April 21, 2023, for the issuance of NPDES Permit No. AR005384. The application has been reviewed by the DEQ's Office of Water Quality and has received tentative approval subject to the terms of this notice.
