

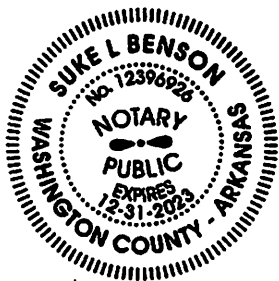

PUBLIC NOTICE OF DRAFT CONSTRUCTION PERMIT CONSTRUCTION PERMIT NUMBER ARG160045C, AFIN 72-00144

This is to give notice that the Arkansas Department of Environmental Quality (ADEQ), Water Division, 5301 Northshore Drive, North Little Rock, Arkansas 72118-5317 at telephone number (501) 682-0622, proposes a draft construction permit for which an application was received on 11/26/2013 in accordance with Regulation No. 6.

Applicant: Eco-Vista, LLC, 2210 Waste Management Drive, Springdale, AR 72762; Latitude: 36°08'38.56" Longitude: 94°15' 20.84"; in Washington County, Arkansas.

The discharge from this existing facility will be made into an unnamed Tributary of Wildcat Creek, thence to Wildcat Creek, thence to Orange Creek, thence to the Illinois River in Segment 3J of the Arkansas River Basin.

Proposed Construction will include a sedimentation pond with a design flow of 2.11 MGD. Modification of the NPDES discharge permit is not required.

ADEQ's contact person for submitting written comments, requesting information regarding the draft permit, or obtaining a copy of the permit and the Statement of Basis is J.D. The comment period shall end at 4:30 P.M. (Central Time) on the 30th day after the publication date. If the last day of the comment period is a Saturday, Sunday or legal holiday, the public comment period shall expire on the next day that is not a Saturday, Sunday or legal holiday. For information regarding the actual publication date along with the actual date and time the comment period will end, please contact J.D. Borgeson at the above address and telephone number or by email at Water-Draft-Permit-Comment@adeq.state.ar.us. Public notice, comments, and hearings will be conducted in accordance with Regulation 8.209 and 8.210 (Administrative Procedures). All persons, including the permittee, who wish to comment on ADEQ's draft permitting decision must submit written comments to ADEQ, along with their name and mailing address. A Public Hearing will be held when ADEQ finds a significant degree of public interest. After the public comment period, ADEQ will issue a final permitting decision. ADEQ will notify the applicant and each person who has submitted written comments or request notice of the final permitting decision. Any interested person who has submitted comments may appeal a final decision by ADEQ in accordance with the APCEC Regulation No. 8.603.
