**Notice of Draft Renewal Permit
NPDES General Permit ARG160000 for
Landfills
located within the State of Arkansas**

This is to give notice that the Arkansas Department of Environmental Quality (ADEQ), Office of Water Quality, 5301 Northshore Drive, North Little Rock, Arkansas 72118-5317 at telephone number (501) 682-0623, proposes a renewal of the Discharge General Permit ARG160000 for discharges from Landfills located within the State of Arkansas under the National Pollutant Discharge Elimination System (NPDES) and the Arkansas Water and Air Pollution Control Act.

Dischargers located within the State of Arkansas requesting coverage will be authorized to discharge to all allowable waters, as set forth in General Permit ARG160000. All receiving waters are a Water of the State, classified for raw water source for public, industrial, and agricultural water supplies, propagation of desirable species of fish and other aquatic life, and other compatible uses.

The submission of written comments by any person will be accepted by the Department during the public comment period. Any interested person may request a public hearing on the draft permitting decision during the public comment period. To submit written comments or request a public hearing on the draft permit, contact the Office of Water Quality at the above address, or by email at Water-Draft-Permit-Comment@adeq.state.ar.us.
