Dear Permittee:

The Department has issued the renewal of Landfill Sediment Pond Discharge General Permit (ARG160000) with an effective date of March 1, 2020. If you wish to continue permit coverage under this general permit after February 29, 2020, please complete and return the Recertification Notice of Intent (NOI) included on the back of this correspondence to the address at the bottom of the page or send it electronically to water.permit.application@adeq.state.ar.us NO LATER THAN JANUARY 31, 2020. Please note your expiring permit will continue through February 29 if you meet the requirements of Section 3.10 of your current permit. If the facility will no longer be in operation after February 29, 2020 and you wish not to renew your coverage, you must submit a Notice of Termination (NOT) before the expiration date of February 29, 2020. Failure to submit either an NOT or a Recertification NOI could result in enforcement action.

Permittees who fail to make a written request to the Director to be covered by this general permit by **January 31**, **2020 will run the risk of operating without a permit**, which would be in violation of the Arkansas Water and Air Pollution Control Act (Ark. Code Ann. § 8-4-101 *et seq.*), and the Clean Water Act (33 U.S.C. § 1251 *et seq.*).
