3 failed stack tests and Consent Administrative Orders (CAO) were issued by ADEQ as follows:

(a) CAO of 3/31/2009 with a fine of \$1,556.25 for exceedance of PM 10 emission from boiler SN-16. The limit was 2.7 pounds per hour for PM 10 and the average tested emissions were 3.7 pounds per hour of PM 10

(b) CAO of 11/6/2010 with a fine of \$1,666.25 for exceedance of PM10 emission from boiler SN-16. The limit was 2.7 pounds per hour for PM10 and the average tested emissions were 5.04 pounds per hour of PM 10

(c) CAO of 9/18/2013 with a fine of \$600.00 for exceedance of Formaldehyde emissions from the Dual Path Kiln #2. The permitted emission was 0.5392 lb/hr of Formaldehyde and the average tested emission was 0.8161 lb/hr of Formaldehyde.

The owner of 100% of the Applicant's equity, NSLC Darlington, Inc., has been subject to Consent Orders dated 6/1/2009, 1/28/2013, and 6/18/2014 with SC DHEC regarding air quality matters. These consent orders have resulted in cumulative fines of \$14,000.
